Whyte said the Buckingham Area Rural Transport Group (BART Bus) has missed the opportunity to submit a grant application and asked Councillors to consider how the town Council might consider supporting the project within the new financial year.

Members discussed the Town Council budgets for the financial year 2020/21.

Proposed by Cllr. P. Collins and seconded by Cllr. T. Bloomfield to increase the precept by 0.81p per week on a band D property. The new cost per band D property would be £169.16 and would be a yearly increase of £4.31 or 2.62% per property.
